2. The 3rd financial upgradation granted to the above officers is subject to, Inter-alia, the following conditions:-

2.1 The financial upgradation will not result in change in the designation of the beneficiaries i.e., the financial benefits are granted with the retention of their old designations and the said financial up gradation shall not confer any privilege related to higher status.

2.2 The financial upgradation under the MACP Scheme shall be purely personal to the incumbents (officers) and shall not amount to actual functional promotions of the officers concerned. Further, it shall have no relevance to their inter-se seniority position, and as such, there shall be no additional financial upgradation for the senior officers on the ground that the junior officers have got higher pay scale(s) under the MACP Scheme. The concept of "Senior-Junior" is quite alien to the idea behind the MACP Scheme.

2.3 If a regular promotion is offered but was refused by the officer, before becoming entitled to a financial upgradation, no financial upgradation shall be allowed, as such an officer has not been stagnated due to lack of opportunities. If, however, financial upgradation has been allowed due to stagnation and the officer subsequently refuses promotion, it shall not be a ground to withdraw the financial upgradation. He shall, however, not be eligible to be considered for further financial upgradation till he agrees to be considered for promotion again and the second the next financial upgradation shall also be deferred to the extent of period of debarment due to the refusal.

2.4 Benefit of pay fixation available at the time of regular promotion shall also be allowed at the time of financial upgradation under the Scheme. Therefore, the pay shall be raised by 3% of the total pay in the pay band and the grade pay drawn before such upgradation. There

shall, however, be no further fixation of pay at the time of regular promotion if it is in the same grade pay as granted under MACPS. However, at the time of actual promotion if it happens to be in a post carrying higher grade pay than what is available under MACPS, no pay fixation would be available and only difference of grade pay would be made available.

2.5 On their financial up-gradation under the MACP Scheme, which is in situ and which may not involve assumption of higher duties and responsibilities, as a special dispensation, their pay shall be fixed under F.R. 22(I)(a)(1) to get their pay fixed in the higher post/grade pay either from the date of their promotion/upgradation or from the date of their next increment viz. 1st July of the year. The pay and the date of increment would be fixed in accordance with clarification No. 2 of Department of Expenditure's O.M. No. 1/1/2008-IC dated 13.09.2008.

2.6 No past cases would be re-opened. Further, while implementing the MACP Scheme, the differences in pay scales on account of grant of financial upgradation under the old ACP Scheme (of August 1999) and under the MACP Scheme within the same cadre shall not be construed as an anomaly.

2.7 Option (exercisable within one month from the date of receipt of this order) for fixation of pay in the higher grade scale(s) based on the date of increment (i.e. 1st July of the year) of the incumbent is also allowable. Such option once exercised shall be treated as final.


3. DOPT vide its letter D.No.62460/US(D)/2010 dated 26.07.2010 has clarified that the benefit of non-functional grade granted to the Superintendent Group (B) officers after completion of 04 years would be treated / viewed as upgradation in terms of para 8.1 of Annexure - I of OM dated 19.05.2009 and the same would be offset against one financial upgradation under MACPS. Therefore, if any of the officers mentioned above has already been granted NFG on completion of 04 years then the above MACP order would not be applicable to such officers.

4. Certain officers in the list above have earlier been granted 2nd /3rd MACP benefits as they had completed 20 /30 years of regular service in their career. Due to the clarification received from the Ministry these officers are now eligible for 2nd /3rd MACP benefits on completion of 10 years in the same grade. In view of the same the earlier order granting them 2nd /3rd MACP benefits from a later date is withdrawn.

5. The above order is subject to decision and final outcome in Writ Petition No. 298/2013 filed against the order passed by the Hon'ble Tribunal in Review Petition No. 03/2011 in OA No. 510/2007 filed by Shri Jitendra S. Newaskar & Ors.

6. **It is advised that before fixation of pay of the individual officer, latest vigilance clearance is verified.**
