

- 1. I state that I am in possession of the annexed by report by the Ld Jt Commissioner that recovery proceedings were initiated against the defaulter Kisan Mouldings Ltd by issuing SCN on 6 August 2021. (annexed herewith as kisan molding pcco.pdf)
- 2. That however, I have no confirmation as to:
 - a. Whether his books of accounts were investigated and found to be deliberately fraudulent concealing such defaults as concerned this complaint and others of similar nature and the quantum of the same.

- b. That whether the said GST amounts from default to SEPL as well as other such suppliers have been refunded with interest to the Govt exchequer and the details therein (Parties and quantum therein).
- c. And the dates of such realized recovery or the timeline envisaged to complete the same process; as already more than a year has passed since our original complaint.
- 3. Annexed herewith also find a letter submitted by us to the jurisdictional DC of GST (on 30/8/2021) for his actions for the claims of said company GST being misleading as also annexed herewith (letter by its CFO dated 22/7/2021) and these proceedings being of judicial nature; our request for appropriate penal actions as per mandate of the law.

We hence humbly request your update on the final reports as mentioned above (but not limited to the same) and/or the timeline within which said actions expected to fruition; so that we can wait for such a time before asking for another update (if not one received automatically).
