Please refer to your above online RTI Application dated 24.02.2022 (CCEM1/R/E/22/00030). In this regard, the information sought for under the above mentioned RTI Application, is supplied as follows :-

Point 1 : The authority to grant NOC for ICT to outside Zone is the cadre Controlling Authority for the respective cadre. This office had only forwarded the applications for ICT, received on medical grounds from Shri Vaibhav Upamanyu and Mrs Kirti Sharma Tax Assistants to the CCA CGST & Customs Pune Zone for necessary action.

Point No 2 : The ICT Applications of Tax Assistants are not being forwarded to Pune Zone due to large scale vacancies in the cadre.

Point No 3 : As per 2(f) of the RTI Act, 2005 the information sought for under this point is not considered as information and hence the same cannot be given.

Point No 4 : Since 2017, 30 Tax Assistants have been transferred on ICT basis from CGST & CEX Mumbai Zone to other zones on compassionate, Handicapped, spouse ground, self and their family's medical grounds. No inspectors/Stenographers/UDC have been transferred on ICT basis to other zones, from 2017 to till date.

Point No 5 : There was no Empowered Committee exist at relevant time when the application of above mentioned Tax Assistants were forwarded.

If you are aggrieved with this information, you may file an Appeal within 30 (thirty) days from the date of receipt of this letter with Shri V V Pandit, Additional Commissioner /First Appellate Authority, Principal Chief Commissioner's Office, 4<sup>th</sup> Floor, 115, New Central Excise Building, M. K. Road, Churchgate, Mumbai 400 020 in terms of Section 19(1) of Right to Information Act, 2005.
