Point No 1 : Out of 9 candidates allotted to CCA, CGST & C.Ex. Mumbai Zone for appointment to the post of Inspector in PwD HH category vide SSC CGLE 2018 only 5 have joined till date. Full details cannot be provided under section 8(1)(j) of the RTI Act, 2005 as it contains third party information.

Point No 2 : Query is not clear.

Point No 3 : With regard to the information under Point No 3 sought for, instructions contained under DOPT's O M No 36035/1/2012-Estt.(Res), dated 29.12.2013 read with

Ministry of Social Justice and Empowerment's Notification No. G.S.R.2 ( E ) dated 30.12.2009 are being followed. The same is available in Public domain.

Point No 4 : The medical certificate issuing authority has confirmed the percentage of disability mentioned in the disability certificate submitted by the candidates to the SSC and the same is accepted.
