3. No option benefit for fixation of under F.R.22(a) is admissible as the promotion is on ad-hoc basis. Further, no pay fixation will accrue to the officers who have been granted financial upgradation to the pay scale of Superintendent, CGST & CX. Group 'B'.

- 4. The promotion is made purely on Ad-Hoc basis in pursuance to the Hon'ble Tribunal's Order dated 03.04.2017 (issued on 17.04.2017) in M.A. No. 232/2017 in O.A. No. 588/2014 amending the Interim Order dated 26.09.2014. The above Ad-hoc promotion will not confer any right for regular promotion and this office reserves the right to cancel the ad-hoc promotion and revert the officer at any time to the post from which he was promoted.
 - 5. The promotions of the Inspectors (Ad-hoc Supdts.) of GST & CX to the grade of Superintendent GST & CX, Gr.'B' are subject to the outcome of various SLP's pending in the Hon'ble Supreme Court on the issue of seniority in the grade of Inspectors and any other orders of the Hon'ble CAT, Mumbai Bench on the said issue.
 - 6. Caste certificate verification has been initiated in respect of officers belonging to SC/ST category by their parent Commissionerate. The concerned Commissionerate is required to inform the outcome of the verification to the Commissionerate where the SC/ST officer is being posted on promotion, for further action in the matter.
 - 7. The above promotions are also subject to the outcome of the WPCT No. 261/2008 filed by Shri Samiran Roy & ors. v/s. Union of India in the Hon'ble Calcutta High Court and the final decision of the Hon'ble Supreme Court in SLP (C) No. 30621 of 2011 filed by Jarnail Singh & Ors v/s Lachhmi Narain Gupta & Ors on the issue of implementation of DOPT's O.M. dated 10.08.2010 under F. No. 36012/45/2005-Estt(Res.).
 - 8. The above order is also subject to the final outcome and acceptance of the order dated 02.11.2018 in 0.A. No.4195/2018 before the Principal Bench of the Hon'ble Tribunal, New Delhi.
 - 9. The above order is also subject to the pending litigation in the case of Shri Surendra Waghmare and the subject DPC and promotion in the rank of Superintendent is being granted without prejudice to the stand of the Union of India that the orders passed and under litigation in O.A. No. 588/2014 are legal and correct, but the present exercise is being conducted in order to meet the urgent requirements of the exchequer in terms of enhancing the cadre strength to meet the GST targets of the Government of India. The promotion order is subject to the stand taken by the Union of India before the learned Tribunal in O.A. No. 588/2014 as also the final decision of the Hon'ble Tribunal therein.
 - 10. The officers on promotions will be on probation for a period of two years in terms of Ministry's Circular No. 91/88 issued under F.No. 12/91/88-Coord., dated 25/04/1988.
 - 11. All the officers should join on promotion by **17.10.2022** positively, failing which it will be deemed as their refusal and the promotion order will be cancelled without any

- further intimation and they will not be offered promotion for a period of one year from the deemed date of refusal.
 - 12. The officers, who are presently posted on Deputation basis/ Loan basis, outside the cadre should immediately be relieved by their controlling officers and shall join at the Office of the Principal Chief Commissioner, GST & Central Excise, Mumbai Zone, on or before 17.10.2022. Their promotion as Superintendent, GST & Central Excise, Gr. 'B' Gazetted, will be effective only on joining in the Office of the Principal Chief Commissioner, GST & Central Excise, Mumbai Zone.
